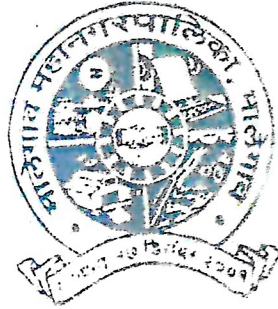
twice a year in the month of January & July regarding maintenance of Fire Prevention & Life Safety measure in good repair and efficient condition as specified in **Sub Section 1**
